



Treasure Cove Bingo Daily Draw
(April 1-30, 2026)

1. Qualified Entrant

- a. A qualified entrant is someone who is 19 years of age or older. BCLC employees, Treasure Cove Casino employees, and Treasure Cove Casino Contract employees are not eligible. (Family members of casino employees who reside in the same household are also not eligible to participate). Voluntary self-excluded and barred persons are not eligible to participate and will not be awarded a prize. Management reserves the right to exclude any individuals from this promotion at its sole and absolute discretion.
- b. Patrons must be an Encore member to receive bonus play.

2. Conditions for Daily Bonus Play Draws

- a. Promotional period: April 1st, 2026, up to and including April 30th, 2026.

3. Daily Draws

- a) Beginning Wednesday, April 1st, 2026, up to and including Thursday, April 30th, 2026, patrons at the Treasure Cove Bingo may receive one ticket per session from 9:00 am up to and including 11:00pm each gaming day. Sunday - Thursday the ticket draws are for \$20 bonus play, Friday and Saturday the 11:00am and 2:30pm session draws are for \$20 bonus play and the 6:00pm and 10:00pm session draws are for \$50 bonus play. 5 winners will be drawn per session.
- b) Saturday, April 11th, 2026, the 6:00pm session draws will be for \$200 bonus play and there will be 5 winners drawn.
- c) A Bingo Cage Representative will draw 5 tickets from the ticket box each gaming day of the promotional period, after the 1st intermission.

- d) A Bingo Caller will call the winning draw ticket number over the bingo PA.
- e) A Guest Services Representative will record slot play under the CMP prize code Bingo20, Bingo50, or Bingo200 depending on the draw that was won.
