

## Super Bingo Cash Draws

### 1. Description of Promotion

At the Evening session (6:00 PM), there will be five draws for \$100, payable by cheque.

### 2. Definitions

- a. **Qualified Entrant** is a person 19 years of age or older, except:
  - i. Employees of Treasure Cove Bingo, as well as family and household members residing at the same address as employees of Treasure Cove Bingo.
  - ii. Employees of British Columbia Lottery Corporation ("BCLC").
- b. Participants in BCLC's Voluntary Self-Exclusion Program (each a "**Self-Excluded Person**").
- c. A **Drawn Entrant** is a Qualified Entrant whose ticket is drawn from a designated draw barrel in accordance with the standard house rules governing draws.
- d. A **Contest Prize** is a prize won in a promotional draw. A Contest Prize is governed by the Contest Conditions and General Conditions below.
- e. The **Promotion Coordinator**, or designate appointed by the Promotion Coordinator, shall be the designated promotion coordinator for this promotion.
- f. A **Session** is a period of time during which a bingo program is played. Treasure Cove Bingo typically offers the following sessions:
  - i. Afternoon - from approximately 11:00 AM to 2:00 PM.
  - ii. Matinee - from approximately 2:30 PM to 5:30 PM.
  - iii. Evening - from approximately 6:00 PM to 9:30 PM.
  - iv. Late Night - from approximately 10:00 PM to 1:00 PM.

### **3. Prizes**

- a. There shall be (5) five daily Contest Prizes at the 6:00 PM session to be won.
- b. The prize shall be \$100 (one hundred dollars) payable by cheque.
- c. The winner(s) of the prize shall be determined by a draw.
- d. The winner does have to be present to win.

### **4. Draw Dates**

Draw dates: April 25, May 30, June 27, July 25, August 29, September 26, October 31, November 28, and December 26, 2026.

### **5. Promotional Conditions**

- a. A Qualified Entrant shall be given an entry ticket at the time of purchasing his/her regular cards for a session. The second half of the ticket shall be entered into a designated draw barrel by the cashier.
- b. Tickets shall be kept in a designated draw barrel located at the cash cage.
- c. Draws shall be conducted after the second intermission has ended.
- d. Two employees shall conduct the draws under camera coverage.
- e. Entries shall be discarded at the end of the draw.
- f. The Contest Prize must be accepted as awarded.
- g. The odds of winning the Contest Prize will depend upon the total number of participants in the draw.
- h. The winner of the draw shall be issued the Contest Prize immediately. If the winner is not identified, the Contest Prize will not be awarded.

- i. The winner of the draw must answer a skill-testing question.
- j. Qualified entrants shall be required to record their name on the winning ballot form:
  - i. to administer this promotion;
  - ii. to administer responsible gaming programs.
- k. The authority of obtaining this information is found in s. 26© of the *Freedom of Information and Protection of Privacy Act* and the *Gaming Control Act*.
