



First 100 (May 1-31 2026)

1. Qualified Entrant

- a) A qualified entrant is someone who is 19 years of age or older. BCLC employees, Treasure Cove Casino employees, and Treasure Cove Casino Contract employees are not eligible. (Family members of casino employees who reside in the same household are also not eligible to participate). Voluntary self-excluded and barred persons are not eligible to participate and will not be awarded a prize. Management reserves the right to exclude any individuals from this promotion at its sole and absolute discretion.
- b) Patrons must have an Encore card to receive bonus play.

2. Promotional Period

- a) Promotional period: Friday, May 1st, 2026, up to and including Saturday, May 31st, 2026.
