

Casino 40th Anniversary Celebration (May 30 – June 6, 2026)

1. Qualified Entrant

- a. A qualified entrant is someone who is 19 years of age or older. BCLC employees, Treasure Cove Casino employees, and Treasure Cove Casino Contract employees are not eligible. Family members of casino employees who reside in the same household are also not eligible to participate. Voluntary self-excluded and barred persons are not eligible to participate and will not be awarded a prize. Management reserves the right to exclude any individuals from this promotion at its sole and absolute discretion.
- b. Must be an Encore member to receive bonus play prizes.

2. Promotional Period

- a. Promotional period: Saturday, May 30th, 2026, up to and including Saturday, June 6th, 2026.

3. Conditions for Weekly Draws

- a. Beginning Saturday, May 30th, 2026, at 9:00am, patrons of the Treasure Cove Casino can receive one ballot at Guest Services from 9:00am up to and including 2:00am, to be entered into two draws for \$9,500 bonus play and \$500 cash, \$4,500 bonus play and \$500 cash, and \$2,500 bonus play and \$500 cash. If claimed before midnight of that gaming day, winners will receive an additional prize of \$1,500 in bonus play and \$500 in cash.
- b. Patrons must fill out ballots clearly and legibly to be eligible to win.

4. Weekly Draws

- a. On Friday, June 5th, 2026, and Saturday, June 6th, 2026, at approximately 8:00pm, a Guest Services Representative will draw three ballots from the draw barrel, to be witnessed by a secondary staff member.
- b. A Guest Services Representative will verify that each winner is not barred or self-excluded.
- c. The winners do not have to be present to win.

- d. A Guest Services Representative will page the winners' names over the P.A. system.
- e. If the winners are not present, a Guest Services Representative will contact them via telephone. If being contacted by telephone, the Guest Services Representative will notify each winner that they have until midnight of that gaming day to receive the additional prize.
- f. The three draws are for:
 - i. Grand Prize: \$9,500 bonus play and \$500 cash. If the winner is in the casino during the draw or claims the prize before midnight of that gaming day, they will receive an additional prize of \$1,500 in bonus play and \$500 in cash.
 - ii. Second Prize: \$4,500 bonus play and \$500 cash. If the winner is in the casino during the draw or claims the prize before midnight of that gaming day, they will receive an additional prize of \$1,500 in bonus play and \$500 in cash.
 - iii. Third Prize: \$2,500 bonus play and \$500 cash. If the winner is in the casino during the draw or claims the prize before midnight of that gaming day, they will receive an additional prize of \$1,500 in bonus play and \$500 in cash.
- g. The winner of the first ballot drawn will win \$9,500 bonus play and \$500 cash, the winner of the second ballot drawn will win \$4,500 bonus play and \$500 cash, and the winner of the third ballot drawn will win \$2,500 bonus play and \$500 cash.
- h. If the winners fail to claim their prize before midnight, they will forfeit the right to claim the additional prize and will be eligible for the main prize only.
- i. The winners have 30 days to claim their prize.
- j. The winners of the Friday and Saturday draws will not have their ballots returned to the barrel.
- k. A patron is eligible to win only one prize per week.
- l. Bonus play prizes will be issued using the prize-tag "GEC-Anvsary".
- m. After the draw on Saturday, June 6th, 2026, a Guest Services Representative will remove all ballots from the draw barrel, to be stored in a secure area for 30 days.
